

Prize of the Bulletin of the Brazilian Mathematical Society

The prize of the Bulletin of the BMS aims to distinguish the best original research article in Mathematics recently published in the Bulletin of the BMS. The judgment is based on the following parameters: originality, relevance, depth, and potential impact on the development of the respective field.

Regulations of the Prize of the Bulletin of the BMS 2024

In its 2024 edition, the BMS Prize will be governed by the following rules:

- 1. The Prize will consist of a diploma and a monetary award of \$1,000.00 (one thousand dollars). If the prize winner works or is a regularly enrolled student at a university and/or educational and research institution based in Brazil, in addition to the mentioned award, the author will be invited, with travel and lodging expenses covered by the BMS, to deliver a plenary lecture at the Biennal of the BMS. In the case of two or more co-authors being awarded, the monetary value of the Prize will be divided equally among them. In the case of two or more co-authors who work or study at universities and/or educational and research institutions based in Brazil, the invitation to the plenary lecture at the conference "BMS Biennial" will be extended only to the youngest co-author.
- 2. The jury of the prize will be composed of the following members: Professors Carolina Araujo, Lorenzo Diaz, Maria Aparecida Ruas, Eduardo Teixeira, Keti Tenenblat, Maria Eulalia Vares, José Felipe Voloch, and Daniel Pellegrino, who will preside.
- 3. Articles published in the BMS bulletin in the years 2023 or 2024 may be nominated for the Prize.
 - 3.1. Articles including members of the BMS Board of Directors among their authors may not be nominated.
 - 3.2. The jury member may not participate in the evaluations of the candidate in situations of potential conflict of interest. Similarly, the selection of reviewers in Article 5c) must take into account possible conflicts of interest. For example, conflict of interest situations includes, among others, when the jury member is a collaborator, a faculty member of the same department, a postdoctoral supervisor of any candidate, a master's and/or doctoral advisor of any candidate.

- Close personal relationship between a jury member and a candidate will also be considered a conflict-of-interest situation. Other conflict of interest situations will be analyzed by the judging committee before the start of the evaluation process.
- 3.3. In order to increase representation in the field of mathematics, a special criterion will be adopted for women researchers who, during the period from 2020 to the year of nomination for the prize, have experienced childbirth or adoption. In these cases, the judging committee may consider articles published from 2022 onwards. For the candidate to be considered under this criterion, the dates of birth or adoption of the children must be specified at the time of nomination for the prize.
- 4. The Prize will distinguish, at most, one research article.
- 5. Nominations for the Prize may be made by any researcher and/or faculty member of a national or international educational and research institution. They must include the following documentation, in English:
 - a) A declaration of no more than two pages explaining the article (complete reference) and why the authors are being nominated for the Prize, justifying the nomination.
 - b) An electronic file in .pdf format of the article.
 - c) A recommendation letter from at least two national or foreign specialists in the candidate's field. The specialists must be chosen so as not to constitute a conflict of interest.
 - d) Information about each candidate, including institution, email address, and URL of the Lattes curriculum or a PDF file with the candidate's curriculum vitae.
- 6. Nominations, containing the documentation listed above, will be sent by email to secretaria@sbm.org.br with the subject "Nomination for the BMS Prize", no later than May 23, 2024.
- 7. Self-nominations will not be accepted.
- 8. The winner(s) of the Prize will be announced during the conference "SBM Biennial 2024", when the award ceremony will also take place.
 - 8.1. There will be no appeal against the decision of the Jury.
- 9. The BMS Council of Directors reserves the right to solve all ambiguous situations and to deliberate on all exceptional cases not covered by these regulations.
